Notification only (option 1 of the form), which does not require payment of either the fee based on the rate table or the revenue stamp, is due in the following cases :

- reproductions of cultural assets and their re-use for volumes that are recognised by the granting institution as having a scientific and academic status (contributions in volumes, proceedings of national and international conferences);
- reproductions of cultural assets and their re-use for volumes and journals recognised by the granting institution as having a didactic and educational content;
- reproductions of cultural assets and their re-use for catalogues of art, exhibitions and cultural events with a circulation of up to 4,000 copies;
- reproductions of cultural assets and their re-use for scientific journals (e.g. Peer Review);
- reproductions of cultural assets and their re-use for publications in newspapers and periodicals in the exercise of the right to report;
- reproductions of cultural assets and their re-use for publications freely accessible by anyone without payment of a price (so-called open access);
- reproductions of cultural assets made independently by anyone (e.g. students, scholars, researchers, university lecturers) for non-profit purposes and not intended for sale;
- reproductions of cultural assets and their re-use for the creation of exhibition, scientific, didactic and educational material for exhibitions and cultural events organised by a department of the Ministry or by public and private institutions for the purpose of promoting the cultural heritage on a non-profit basis. In case of requests relating to a large number of pictures, they are free only within the framework of institutional collaboration agreements. It should be noted that the admission fee is not sufficient in itself to characterise a valorisation initiative as profit-making, but the totality of the circumstances in which the initiative is implemented must be assessed.

To obtain authorisation, an application (option 2 of the communication/authorisation form) must be submitted, accompanied by an appropriately cancelled administrative revenue stamp (€ 16.00). Alternatively, the application can be electronically stamped using the Buy @e.bollo service and sent by e-mail, together with the required attachments.

The payment of the revenue stamp is not due by the administrations of the State, Regions, Provinces, Municipalities, their consortia and associations, as well as mountain communities, and ONLUSes, which may avail themselves, respectively, of the exemption in accordance with table all. B, artt. 27-bis and 16 of DPR 642/1972.

Following publication, a copy of the work produced, also in pdf format, must in any case be delivered to the State Archives of Bologna.
